


Legislation Passed in the 2018 Legislative Session and Community Input Survey Results

EDUCATION	
Computer Science	HB 2607: Appropriates \$500,000 to the Department of Education (DOE) and requires the DOE to implement a statewide computer science plan for public school students in K-12.
Constitutional Amendment	SB 2922: Proposes amendments to the Constitution of the State of Hawaii to authorize the Legislature to establish, as provided by law, a surcharge on investment real property to support public education.
Resource Recovery	HB 2025: Authorizes the DOE to issue grants to establish a composting grant pilot project in DOE schools.

HEALTH & SAFETY		
Prescription Drugs	SB 2646: Requires prescribers of certain controlled substances to consult the State's Electronic Prescription Accountability System before issuing a prescription for the controlled substance.	
Opioids	HB 1602: Requires the inclusion of a label warning of the risks of addiction and death on the packaging of any opioid drug dispensed by a health care professional or pharmacist.	
Water Pollution & Sunscreen	HB 2025: Bans the sale, offer for sale, or distribution of all sunscreen products containing oxybenzone or octinoxate without a prescription from a licensed health care provider - beginning 1/01/2021.	
Public Safety	SB 2858: Requires the State to consider hurricane resistant criteria when designing and constructing new public schools for the capability of providing shelter refuge.	
Address Confidentiality	SB 2346: Establishes the Address Confidentiality Program within the Attorney General's Office to help survivors of domestic abuse, sexual assault, and stalking to relocate and keep their physical addresses confidential.	

AGRICULTURE		
Live Stock Feed Mill	HB 2538: Construction and equipment for the establishment of a feed mill to be located anywhere on Oahu and requests release of \$4 million for the planning and construction of the live stock feed mill.	
Environmental Protections	SB 3095: Bans chlorpyrifos, effective 1/01/2019. Requires users of all restricted use pesticides (RUPs) to submit an annual report of all RUPs to the Department of Agriculture (DOAG). Requires DOAG to develop a pesticide drift monitoring study and submit a report to the Legislature before the 2020 regular session.	


TRANSPORTATION		
Abandoned Vehicles	HB 2442: Mandates the removal of abandoned vehicles from public property within 10 business days.	
Mopeds	SB 2854: Creates a fine up to \$100 for moped owners who do not properly register their vehicle nor attach their plate, tag, or emblem.	
Rental Vehicle Tax	HB 2601: Increases the rental motor vehicle surcharge tax for lessees without a valid Hawaii driver's license by \$2 for each day, or portion of a day, that a rental motor vehicle is rented.
