Aloha Neighbors and Friends,

Happy Autumn! It's been a very busy time between Legislative Sessions this year with many informational briefings being held at the Capitol. Thank you to those who have made the trip to town to see and hear first-hand the information presented on a wide variety of topics and the issues we face in our community and State. Check out **Capitol.Hawaii.gov** for a list of current briefings.

As you may know, the Hawaiian Electric Company's (HECO) latest proposals to the Hawaii Public Utilities Commission (PUC) are topics of significant interest for our community. You may have heard that these proposals include new fees on HECO customers (including a \$55 monthly charge for all customers and a separate \$16 monthly interconnection fee for PV customers), as well as discontinuing the current Net Energy Metering (NEM) program, with a significant decrease in the amount paid to PV customers who provide power for the grid.

The Hawaii PUC is soliciting comments from the public on these plans through October 6, 2014. Your comments will help the Hawaii PUC in its initial review and assessment of the plans. Please take a few minutes to let the Hawaii PUC know your thoughts on these proposals before the upcoming October 6, 2014 deadline.
