Aloha Friends and Neighbors!

Thank you to everyone who participated in the Waialua Town Hall with Senator Riviere, Representative Quinlan, Councilmember Heidi Tsuneyoshi, and my office! I greatly appreciate everyone coming out and sharing their concerns and opinions. Thank you so much for engaging with us to better represent your needs!

At the Town Hall, I shared my 2019 Bill Package which I based off of the survey that members of the District 45 Community completed. Full survey results are available at **RepMatsumoto.com!** Based on what was shared, my office worked hard to create bills that would address the issues that are most important to you and your families. This Session, my bill package includes bills that address cost of living, homelessness, health and safety, and government transparency.



My Bill Package



My cost of living bills focus on reducing taxes on your income, medical services, food, and feminine hygiene products.

My homelessness bills focus on creating more beds at for the licensed residential crisis shelter and giving money to the non profits who are on the ground working with the homeless population in our state.

My health and safety bills focus on kupuna care, opioid abuse prevention and protection for health insurance coverage. My government transparency bills focus on creating databases which will make information more available and increase accountability.

Lastly, MDPT provided a checklist on the first steps in an emergency/Post Hurricane Checklist as they determined Mililani's biggest natural threat is a hurricane.

COST OF LIVING



GIVING YOU BACK MORE MONEY BY LOWERING TAXES

HB 1592 - eliminates the general excise taxes on food, medical services, and feminine hygiene products.

HB 1591 - reduces your income taxes

HB 1149 - establishes an income tax credit for employers who create on-site early childhood education facilities.

HOMELESSNESS



FINDING SOLUTIONS THROUGH MENTAL HEALTH AND NONPROFITS

HB 1594 - increases the number of residential beds available for those experiencing a mental health crisis; individuals stay in the shelter to become stabilized and connected to resources.

HB 1145 - requires the Departments of Health & Human Services to pay organizations within 90 days of the award of a grant. Late payments destabilize organizations which serve vulnerable populations.

HEALTH & SAFETY



IMPROVING YOUR WELL-BEING AND CARING FOR OUR KUPUNA

HB 1148 - prohibits health insurance companies from making changes to your policy or contract prior to your renewal date.

HB 734 - requires pharmacies to include an envelope to mail back unused opioids for proper drug disposal at no extra cost to you.

HB 736 - allows residents of care homes to have video monitoring and prevent abuse.

GOVERNMENT TRANSPARENCY



KEEPING THE STATE ACCOUNTABLE AND SHARING INFORMATION

HB 1593 - creates a financial database to be used across state agencies, so we can see how taxpayers' monies are being spent.

HB 733 - establishes the position of Chief Data Officer to manage the sharing of state data.

HB 1146 - requires past performance to be considered in future bid selection of contractors.
