Conference Week at the Capitol

Aloha Friends and Neighbors!

This week at the capitol is conference week! Every Bill and Resolution that will be considered this Session has already been heard. At this point in the session, all of the bills that are still alive have been passed through both the House of Representatives and the Senate. The next step is for the bills to go through conference committees for the members of the House and Senate to agree on the version of the bill that is best and determine whether to pass them in their current forms or engage with one another in a conference to compromise on the final form of the bills. Although formal testimony cannot be submitted at this point in the legislative process, your voice can still be heard!

I will be using the mid session surveys that you filled out to guide my vote as I meet in my conference committees and I encourage you to call or email my office and the offices of other legislators to share your opinions on bills that may soon become laws.



My Bills and Resolutions



This Session, I have two bills and one Resolution that are still moving through the conference process. House Bill 1146 is relating to basing

procurement of government contracts on past performance and House Bill 1593 would create a uniform financial database for the state to use. These measures are designed to increase government transparency. I also have House Concurrent Resolution 56 relating to child abuse prevention training for educators.

Please be sure to submit testimony to support these measures! Thank you for your input and support as I finish this year's legislative session!

I have had the honor for the last six years of being a co-convenor for the Women's Legislative Caucus and the privilege of spearheading the Easter Basket Event each year. The Easter baskets included soaps, towels, kitchen supplies, diapers, cleaning products, and other household items. 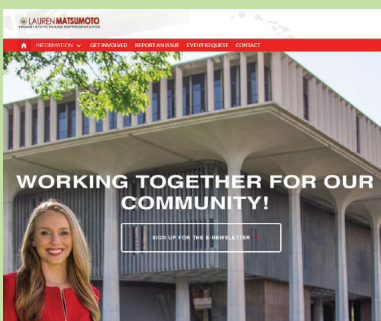

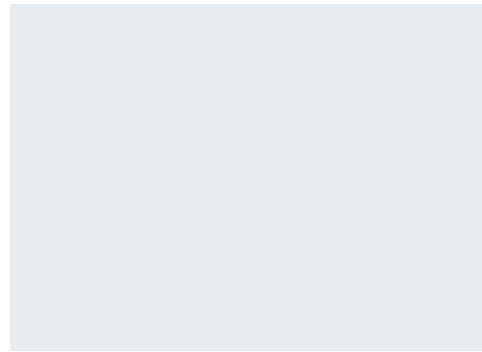
